RESOLUTION #R-98-2009

A RESOLUTION OF THE LOVELAND CITY COUNCIL APPROVING A MATERIAL MODIFICATION TO THE CONSOLIDATED SERVICE PLAN FOR CENTERRA METROPOLITAN DISTRICTS NOS. 1-4 PERMITTING THE EXCLUSION OF CERTAIN UNITS OF RESIDENTIAL REAL PROPERTY FROM CENTERRA METROPOLITAN DISTRICTS NOS. 2 AND 4

WHEREAS, the City of Loveland (the "City") City Council (the "City Council") approved a Consolidated Service Plan for Centerra Metropolitan Districts Nos. 1 through 4 ("Service Plan") on January 20, 2004, as evidenced by City Council Resolution #R-7-0004; and

WHEREAS, pursuant to Section I.A.4. of the Service Plan, any boundary adjustment which adds to or subtracts from the total acreage of Centerra Metropolitan Districts Nos. 1 through 4 (the "Districts") is considered a material modification of the Service Plan and requires approval of the City Council; and

WHEREAS, at the request of McWhinney Real Estate Services, Inc. ("Developer"), the developer of Centerra, the City Council approved, on June 5, 2007 in Ordinance No. 5195, an amendment to the Millennium General Development Plan ("Millennium GDP"), which amendment permitted residential uses located on Millennium GDP Parcel A-1 within Centerra Metropolitan Districts Nos. 2 and 4 ("Districts Nos. 2 and 4"); and

WHEREAS, to remain consistent with the original intent of the Service Plan that only commercial property be located within the boundaries of Districts Nos. 2 and 4, the City Council, at the request of the Developer and the Districts, approved, on June 5, 2007 in Resolution #R-48-2007, a material modification to the Service Plan permitting the exclusion of future residential units to be located on Parcel A-1 from the boundaries of Districts Nos. 2 and 4; and

WHEREAS, in 2009, the Developer asked the City Council to approve an amendment to the Millennium GDP (the "Amended Millennium GDP") to redistribute residential uses therein, which Amended Millennium GDP the City Council approved on May 5, 2009 in Ordinance No. 5417; and

WHEREAS, the Amended Millennium GDP resulted in the redistribution of residential uses ("Redistributed Residential Units") into the boundaries of Districts Nos. 2 and 4; and

WHEREAS, to remain consistent with the original intent of the Service Plan that only commercial property be located within the boundaries of Districts Nos. 2 and 4, the Developer and the Districts desire to exclude the Redistributed Residential Units from the boundaries of Districts Nos. 2 and 4, which exclusion represents a material modification to the Service Plan and requires City Council approval; and

WHEREAS, the Boards of Directors of Districts Nos. 2 and 4 desire the City Council to approve a material modification to the Service Plan permitting the exclusion of the Redistributed Residential Units from Districts No. 2 and No. 4; and

WHEREAS, such material modification is similar to the City Council's approval on June 5, 2007 in Resolution #R-48-2007 of a material modification to the Service Plan permitting the exclusion of future residential units to be located on Millennium GDP Parcel A-1 from the boundaries of Districts Nos. 2 and 4;

WHEREAS, notice of a public hearing before the City Council for its consideration and approval of this proposed material modification to the Service Plan was duly published in the *Loveland Reporter-Herald* on September 15, 2009, as required by law and as evidenced in the Affidavit of Publication attached hereto as Exhibit A; and

WHEREAS, notice of the public hearing before the City Council was also duly mailed by first class mail, on September 15, 2009, to all interested persons, defined as follows: (1) the owners of record of all property within Districts Nos. 2 and 4 as such owners of record are listed on the records of the Larimer County Assessor; (2) the division of local government, and (3) the governing body of any municipality or special district which has levied an ad valorem tax within the next preceding tax year, and which has boundaries within a radius of three (3) miles of Districts Nos. 2 and 4's boundaries, as evidenced in the Certification of Mailing Notice of Hearing and Publication dated September 16, 2009, attached hereto as Exhibit B; and

WHEREAS, pursuant to the provisions of Title 32, Article 1, C.R.S., the City Council opened the public hearing on this proposed material modification of the Service Plan at its October 6, 2009 regular meeting but adopted a motion to continue this public hearing to Council's October 20, 2009 regular meeting at which time the public hearing was held; and

WHEREAS, the City Council has considered this material modification to the Service Plan, and all other testimony and evidence presented at the hearing.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LOVELAND, COLORADO:

1. That the hearing before the City Council was open to the public; that all interested parties were heard or had the opportunity to be heard; and that all relevant testimony and evidence submitted to the City Council was considered.

2. That the City Council hereby determines that the requirements of Section 32-1-207 (2), C.R.S, relating to the approval of a material modification to the Service Plan for the Districts; the requirements of Sections 32-1-204 (1) and (1.5), C.R.S., relating to the notice of the hearing by the City Council; and the requirements of Section 32-1-204.5, C.R.S. relating to the approval by the City Council have been fulfilled in a timely manner.

3. That the City Council hereby finds that the District's proposed material modification to the Service Plan is in the best interests of the Redistributed Residential Units to be excluded from Districts Nos. 2 and 4.

4. That the City Council does hereby approve the material modification to the Service Plan permitting the exclusion of the Redistributed Residential Units to be located within the boundaries of Districts Nos. 2 and 4 as a result of the Amended Millennium GDP approved by City Council on May 5, 2009 in Ordinance No. 5417, following approval of said exclusion by Districts Nos. 2 and 4's Boards of Directors and the Larimer County District Court, pursuant to Sections 32-1-501, et seq., C.R.S.

5. That nothing herein limits the City's powers with respect to Districts, the properties within the Districts, or the improvements to be constructed by the Districts and nothing herein shall be considered as the City Council's approval of any other material modification of the Service Plan, as previously amended, except as expressly stated herein.

6. That the City Council's findings are based solely on the evidence presented at the public hearing and that the City has not conducted any independent investigation of the evidence.

7. That this Resolution shall take effect on the date and at the time of its adoption by the City Council.




